The purpose of the Council of Delegates (COD)

...is to govern entities and activities of the Christian Reformed Church in North America (CRCNA). In fulfilling this responsibility, the COD shall

- Transact all matters assigned to it by synod and serve in the interim of synod with matters which cannot await action by the assemblies themselves . . . and submit all such actions to the next meeting of the assembly for approval.
- Lead the integrative ministries of the CRC in light of the Mission, Vision, and Callings established by synod, providing recommendations to synod when the Missions, Vision, and or Callings need to be reconsidered.
- Cooperate with the educational institutions affiliated with the denomination and World Renew as well as other CRCNA boards toward integrating the respective missions of those institutions and functions into the denominational ministry program.
- Provide an intermediary role that serves three purposes: (1) To receive and understand input from congregations and their members (constituents), (2) bring the work and excitement of ministry to congregations and their members, and (3) understand the church—its various contexts and times—to such a degree that the COD assists in casting an appropriate vison for the future growth of the church.

Classis is requested to nominate one person, to be elected by synod 2022 to serve as classis Huron's representative on the COD.

Classis is presented with two names, one to be selected.

General Work Background

Born and raised in Ontario, Peter started his career in 1972 with the Government of Ontario focusing on natural resources management and environment protection. - consolidation/role of agencies and ministries and the future role of Classes among many other recommendations. As part of the Task Force, Peter and Kathy Vandergrift played an important role in assisting the Task Force to better understand and appreciate the bi-nationality issues that impact leadership roles, culture and decision-making across our borders.
- Suggested pathways to effective governing structures for local church, classis and denominational (synodical) interrelationships. Spent considerable time listening to the 47 classes and local congregations on the future direction of the denomination with respect to accountability, ecclesiastical relationships and support of ministries
- As the sole Canadian on the interview panel, selected Steven Timmerman as Executive Director of the CRCNA. Developed the selection criteria for the panel
- Peter has built a good rapport with leaders in the CRCNA through his involvement with the denomination including Colin Watson Sr., Jules Medenblik, Joel Boot, Ida Kaastra-Mutoigo, Kathy Vandergrift and a number of other key leaders
- Have been requested to participate in a number of other denominational projects
- Requested to comment on the recent SALT report
