Abuse of Power

When the COD met in June 2021, in lieu of Synod, it instructed the Executive Director to make recommendations to the COD for improving the appeal process. The context for the mandate was a concern that the appeal process as described in Church Order Article 30a isn't particularly well-suited to deal with cases involving allegations of abuse. In response, Executive Director Colin Watson appointed a small task force to work on this mandate.

Over the past few months, the task force has met several times and we are making good progress identifying places where the appeal process seems especially weak in effecting a just and compassionate response to allegations of abuse. What has been particularly helpful for our discussions has been hearing from those of you who have been involved in an appeal process regarding allegations of abuse. If you would like to share your thoughts, experiences, and/or ideas, we would certainly welcome your input. In order to facilitate this, Safe Church has set up a google form that will allow you to submit your comments anonymously and confidentially.
