Welcome/Announcements by Rev. Bart Eisen who led in a time of worship

Art. 2 First Morning Session

• The Credentials Committee reported on the attendance. River City CRC and Vanastra Community CRC were not represented.

The Campus Ministers were attending a Campus Ministers' Conference.

- Covenant of Office Bearers was signed by all first-time delegates.
- Classis Huron Primer was highlighted
- Declaration of Conflicts of Interest was explained
- Classis Huron was Constituted

Art. 3 Round Table Session

Rev. Sid Couperus (First CRC, Owen Sound) used the new classis ministry plan to focus on our Covenantal Responsibilities and Tasks.

The Round Table prayer time was based on Lord's Day 12, Q&A 32: But why are you called a Christian?

Pastor Sid gave prayer instructions, to pray for ourselves, church leaders, the classis and synod.

Art. 4 Waterloo Campus Ministry Report

Carolyn Kleefman, chair of the WCM Board, informed classis that the search committee has offered Melissa Burmaster, currently the interim campus minister, the full-time campus minister position.

Waterloo CRC will be the calling church, extending the official call to Melissa.

Melissa joined us via *Google Meet* as she was at a campus ministers' conference in Hamilton. She shared a video with the delegates (https://youtu.be/k h5ilqhA88). This video included interviews of students and faculties.

She also reported on the work on the two campuses. There are 46,000 students at the

University of Waterloo and 20,000 at Wilfrid Laurier University.

She is already developing plans for the next season.

Melissa encouraged the delegates to share with students at home that there are exciting ministry opportunities at university campuses.

Motion to affirm the appointment of Melissa Burmaster as Waterloo Campus minister.

A church visitors' report to Bethel CRC, Acton, from Rev. John Vanderstoep (The Bridge) and Victor Laarman (Collingwood CRC) was received.

Rev. Tim Keep (Trinity CRC, Goderich) reported for the Oversight Committee, on the progress of the Vanastra Community CRC. The committee members will attend a planned congregational meeting.

Art. 13 Classis Huron Mission Team

Joan Brady (Classis Huron Mission Catalyzer) reported for the CHMT.

- The second *Moving Forward in Faith* conference is planned for this fall.
- She also introduced the new Creative Outreach Venture Fund 2.0. This fund utilizes a
 portion of their budget to support and encourage Classis Huron churches and ministries
 to engage in their communities in a missional way.
 Joan reported that one application was received already.
- A Youth Catalyst proposal will be presented at the September session of classis.
- Joan is available to support local churches with their outreach ministry opportunities.

Rev. Sid Couperus (Prayer Catalyzer) reported on the Multi-Classis Pastors' Retreat and the planned retreat for February 2026, with invitations to include the retired ministers.

Motion to approve the work of the Classis Huron Mission Team.

Art. 14 Other Classical Ministries

Safe Church

Rev. Carel Geleynse (Classis Huron Safe Church Coordinator) reported that there are seven new members on the classis team. The team's mandate calls for one representative from each of the Classis Huron churches.

He referred to the printed report in the agenda and also cautioned about the abuse of power in the church.

Motion to approve the work of the Safe Church Team.

Classical Counsellor Reports

The classis clerk reported for the classical counsellors on:

Blyth; Lucknow Community;

Maranatha, Cambridge; Orangeville;

Water Street, Guelph; Waterloo Campus Ministry;

Stratford extended a call to Nick Bierma, to serve as the Co-pastor, and this call was accepted. They have an anticipated start date of August, 2025. Nick is the former pastor at Kelowna CRC, where he served as their pastor for 12 years.

Art. 15 Denominational Reports

Council of Delegates representative Peter Meerveld used a PowerPoint to explain
the structure of the denomination, covering the different agencies and the
governing bodies. He also highlighted several denomination issues, like a decline in
membership and the Ministry Shares. He pointed out that the revenue for our
denomination is dropping.

Sharon Buisman (elder at New Life CRC, Guelph) led in prayer for our denomination.

- Revs. Ray Vander Kooij (Clinton CRC) and Jay Crossen (Exeter CRC) reported on the agenda of Synod 2025. Several agenda items were highlighted. The candidacy committee is presenting a revised journey for Commissioned Pastors towards the Minister of the Word position. The reports of three task-forces were mentioned.
- Rev. Shawn Brix reported for Calvin Theological Seminary using a PowerPoint.
 90 % of Canadian Seminarians are studying remote.

A new curriculum for the students was introduced, training to deal with mental health issues.

Canadian tuition dollars are treated on par with the US dollar, while scholarships are also available. Shawn responded to several questions.

Art. 16 Christian Reformed Church in Canada

A year ago, a letter was circulated to the Canadian CRCs, about "Declaration of Readiness for a Distinct Christian Reformed Church of Canada". Community CRC, Kitchener requested classis to have a discussion about how to respond to that letter.

Rev. Tom Bomhof (Community CRC) explained the history of the movement that is directed toward a more Canadian focus of our churches.

He mentioned that his council is not sure how to deal with this letter.

The chair invited one delegate from each church to report on the responses of their respective councils to the "Declaration of Readiness..." letter:

- It gives a richer environment.
- Not a big thing.
- Interested, but nothing definite yet.
- No impact.

- Not knowing how to respond.
- Not pursuing it.
- Keeping an eye on it.
- Not many conversations.

- Not responded yet.
- Not discussed it.
- Not discussed this.
- Not much interest in (national) separation.
- It may have some traction.
- No appetite for it.

- Talked about it, keep an eye on it.
- It is hard to separate from other (political) issues.
- Not much appetite for it.
- Not much conversation.
- Discussed it a bit, living in a different culture.

Rev. Victor Laarman (Collingwood CRC) prayed for our churches and for the denomination.
