7.1 CMC Report

The Classis Ministry Committee consists of representatives of all ministries/committees within Classis Huron: Chair, Rev. Ralph Wigboldus; Vice-chair, Rev. Amanda Bakale; Classis Ministry Leadership Team, Rev. Stephen Tamming; Home Missions, Rev. Andrew Vis; Safe Church Committee, Atie Ott; Financial Resources Team, Clarence Louter; Huron Campus Ministry (Guelph), Rev. David Tigchelaar; Huron Campus Ministry (Waterloo), Bill Los; Youth Ministry, Lesli Van Milligen; Treasurer John Bell, ex-officio, and Stated Clerk, Rev. Vic Vandermolen, ex officio.

Since the last meeting of Classis, CMC continues to monitor and encourage the various ministries that are part of Classis. The discussion on Discipline as Healing as a follow up to the September classis discussion, with Rev. Jack Vos leading that discussion, has been postponed until September 2015 due to the various issues that need to be addressed. CMC approved the ordination examination of Paul De Weerd [Vanastra CRC] for the February 2015 meeting of Classis. It also approved the request from River City for a grant of \$1,000 to attend a worship symposium – funds to be drawn from the Leadership Development Fund. CMC also approved the attendance of the Clerk and the Vice-Chair of CMC to attend a Classis' leadership meeting in Burlington on January 20-21. The meeting was called by Canadian Ministries Director, Rev. Darren Roorda for the purpose of discerning together how to strengthen the effectiveness of classis and its leaders in such a way that will engage local churches through to denominational entities. In this regard CMC also approved the request that it provide \$400 to help defray costs.

CMC is continuing its review of the Stated Clerk's job description, as per the discussions at the September 2014 meeting, and anticipates presenting an updated description for Classis to consider at the May 2015 meeting. CMC agreed to address the Elder/Deacon Task Force report that was completed in November and have it discussed at the May 2015 meeting of Classis, that report is attached to this Agenda.

CMC discussed the matter of annual Church Visits, and has sent a letter to all churches encouraging the practice of church visits, and also encouraging that there be an atmosphere of openness and frankness in these discussions.

In reviewing the decisions made re locations of future Classis meetings it was agreed to hold the February 2015 meeting in Palmerston and the May 2015 meeting in Waterloo [see additional information re Classis meeting dates and locations in Article 17 of this Agenda.

The next meeting of CMC will be in April 2015

7.2 Administrative Committee (AdCom)

The Administrative Committee of Classis (AdCom) works on behalf of classis between meetings. AdCom consists of Rev.Ralph Wigboldus (chair), Amanda Bakale (vice-chair), Rev. Stephen Tamming, and stated clerk Rev. Vic Vandermolen. Since the last meeting of classis AdCom has met to respond to issues raised at the last meeting of Classis, and also to address a number of new matters, which have subsequently been referred to CMC and addressed in its report above.

7.3 Stated Clerk

The Stated Clerk serves as secretary of Classis Huron, its Classis Ministry Committee and its Administrative Committee (AdCom). His job description, [set out in the Rules of Classis] is undergoing a comprehensive review that will likely result in CMC recommending some changes for Classis to consider. In that regard, the Clerk has gathered substantial information regarding the role of a Stated Clerk, including varying job descriptions. At the direction of CMC he is in the process of preparing a draft job description, to be presented to CMC, and subsequently to Classis, hopefully at the May meeting for final approval.

The Clerk continues to respond to ongoing requests for information and direction from individual members, church leadership, classis committees, and denominational offices.

In the period of September 17 to the time of writing this report, the Clerk has:

- dealt with/responded to some 107 telephone conversations and requests.
- attended, prepared agendas for, written minutes for, and did follow-up for three AdCom meetings, two CMC meetings, and one Classis meeting. This is in addition to meetings and conversations with others re various issues dealing with matters relative to Classis and its member churches.
- completed the scheduling/coordinating of one ordination examination.
- completed the pulpit supply schedule for one-half of the church year [January-May 2015].
- at the invitation of Canadian Ministries Director, Rev. Darren Roorda, attended a two-day meeting of all Canadian Stated Clerks at the CRCNA offices in Burlington, along with CMC Vice Chair Rev. Amanda Bakale [see CMC report]
- responded to and been involved in the needed follow-up work regarding more than 240 email conversations

 - 16.1 Disability Concerns: WHERE ARE YOU AT?

We call ourselves a church family, each one of us has a place, each one of us belongs. Yet when we read the one article in the "Ministry Report to Classes and Councils" we see a different story. The article on "Disability Concerns" states "A recent study showed that one-third of families who have children with disabilities left their congregation because they did not feel welcome. Some left the Christian faith entirely". Surely this would not happen in our church, after all we are now a caring church. Much more caring now than we used to be when we more or less only showed pity to those with disabilities because they didn't fit in with what we as church had to offer. Is that where your church is at, being a caring church? We now value them and help to provide for them. Isn't that enough?

What does your "Church Policy on Disabilities" say? It probably has a sentence that saysour church values people with disabilities like all other people. It probably will say....our church will do what it can to integrate people with disabilities into all programs and activities sponsored by the church. That states that we go beyond caring. That states that we will be intentional about including them in the life of the church encouraging them to participate, like all members of the church family, every-one using the abilities, the gifts, they have. Look at the parable of the Great Supper. The master, when he realized he had left-over food because the invited did not show up, did not tell his servants to take it out to the poor, and the maimed, and the lame, and the blind. Yes, that would have been caring for them. No, he sent his servants out to bring them in, to make them feel that they belong Maybe we need to open the door to look at the whole picture and see how disabilities impact our church. Disabilities come in many forms; Physical, Intellectual, Sensory and Mental. It touches the lives of quite a number of people in our congregations. It would probably be a good time to review our "Church Policy on Disabilities" to see if there are any gaps that need to be addressed. When we look at the "Position Description of the Church

Advocate", we see that this ministry often is similar to the task of deacons. Working hand in hand with each other will create a strong ministry for those with special needs. The Ontario government legislation (AODA) supports what the denomination has been encouraging for many years. When we follow the Lord's plan for His church and how to deal with those who have unique needs, we will likely be complying with most of the standards the government has in place. Plan to attend the conference this spring that explores what stage your church is at in regards to dealing with disabilities. Let's walk ahead as a family where no one is left out, all are welcome and included.
