**Art 1. Welcome, Devotions & Opening:**

- 1.1 Rev. Craig Hoekema (Bethel CRC, Acton) welcomed the delegates.
- 1.2 Rev. Ken Labb   (Palmerston CRC) opened with devotions, based on Cor. 5: The old has gone, the new is here! We have been given the ministry of reconciliation.
- 1.3 The clerk reported that a quorum was present and the officers were in place.
- 1.4 The chair declared Classis Huron constituted and highlighted some of the Zoom protocols.

**Art. 2 Church Visitors Report**

- 2 Rev. Victor Laarman (Collingwood CRC), one of the church visitors, explained the steps that were taken and their findings/observations. He highlighted the summary of the church visitors' report.
- 2.1 **Motion #1:** That Classis Huron recognize Cornerstone CRC as an emerging congregation under the supervision of Stratford CRC (at the nearest appropriate opportunity).  
Rev. Victor Laarman, reporting for the church visitors, moved motion #1. Delegate Dave Timmerman supported the motion.  
Several comments of appreciation for the work of the church visitors were shared.  
The delegates voted by Zoom poll. *The motion passed.*
- 2.2 **Motion #2:** That Church Visitors be commissioned to meet again with the leadership of Community CRC and Cornerstone CRC in May 2026 to assess ongoing relationships, shared ministry considerations, and emerging concerns.  
Rev. Victor Laarman moved motion #2. Rev. Ken Labb   supported the motion.  
It is assumed that the same church visitors will continue that conversation.  
The delegates voted by Zoom poll. *The motion passed.*
- 2.3 **Motion #3:** That AdCom appoint Church Visitors to provide oversight and guidance to Community CRC, particularly regarding its "Statement on the HSR" and its alignment with denominational decisions.  
Rev. Victor Laarman moved motion #3. Delegate Ron Jack supported the motion.  
It was noted that a healthy dialogue with classis is important.  
The delegates voted by Zoom poll. *The motion passed.*
- 2.4 **Motion #4:** That AdCom review how Classis Huron communicates to congregations their right to request Church Visitors, appeal council decisions, and seek assistance in situations of

significant conflict.

Rev. Victor Laarmann moved motion #4. Rev. Martin Dam supported the motion.

The delegates voted by Zoom poll.

*The motion passed*

A question was raised about classical appointments for Cornerstone CRC.

This is to be discussed by AdCom following this meeting.
